VIII. Old Business

- a. Alumni Association Structure (All) need to make the bylaws less specific to allow flexibility because the bylaw changes need to be approved by the Board of Governors. The approach was to create policies that are referred to in the bylaws so we can edit those as needed.
 - i. Bylaws Jamie reviewed the proposed changes. Stacy drew attention to the Lifetime membership referenced in Article II Section 1. Phil recommended a different approach to the way we manage the terms of chapter officers so they don't have to wear two hats and we can fill the role. We will incorporate the changes that legal has sent to us and aim to get a final version in front of the board for a virtual vote over the summer.
 - ii. Chapter Policy
 - iii. Financial Policy Lisa inquired about purchases that would be prohibited. The group agreed that we should research what some of the prohibited items would be to make that clearer. Lisa also asked questions about the way request of funds is worded. These need to be clarified. Jeanne asked if the split of funds would also apply to scholarship donations. The group agreed that we should clarify how that process will work.
- b. Travel Program (Tucker-Potter) sub committee created a short list of possible trips and then surveyed the people who have participated in the trip before as well as those who have expressed interest in participating in the future. The Greek Islands was narrowly the first choice and the sub committed is researching to determine which trip fits the needs of the Alumni Association.
- c. Slate Portal (Tucker-Potter) The Board will be getting an email to set up their account in the new portal to test it out. The current version is a more base model and we can start to look at expansion and ways to create a members portal.

IX. New Business

- a. Change in travel reimbursement procedures Stacy reviewed with the board that we can no longer sign the reimbursement over through the form. If people want to donate their reimbursement, we will issue a check and that check can be signed back to the Foundation. We also need to get reimbursement requests in within 30 days of the trip. There are some situations where the amount shown on a receipt might not reflect total costs (i.e. if someone uses points or does a switch and the receipt only shows the difference in what was paid. We can only reimburse up to what the receipt says, so be mindful of things that may affect that total.

X. University Update (Thomas)

a. HLC financial assessment annually that show our stability. Financially very strong. Reserves and endowments. Haven't tapped into reserves in her time at Truman. A year of expenses on hand. Schools that are in trouble spend their endowment in ways that aren't approved and we don't do that. Debt. Truman has recently paid down \$30 million in debt by refinancing and paying down at a time when other schools are taking on more debt. Maintenance and Repair. Academic programs. Net increase in programs of 36 microcredentials all the way to master's. Declining enrollment doesn't necessarily indicate poor financial health. The problem is when a university bases their budgets on enrollment projections they can't meet and create a deficit budget. We set conservative budgets in line with realist enrollment projections and not on what we hope enrollment will be. Challenged Admissions to a 10% increase in all categories. They expect to be up in all categories except for transfer. Graduate admissions is projected to be up more than 10%. Truman Experience Weekend (show and tell versus go and do). Legislative updates.
