Students are precluded from taking graduate courses if they have taken an equivalent undergraduate course.

ADMISSION REQUIREMENTS:

- Hold a baccalaureate degree from an accredited institution.
- Have a cumulative grade point average of 3.00 or higher. Consideration is given to students who have a 3.00 GPA in the last 60 credits of coursework
- Truman Accounting or Business Administration graduates: GMAT not required. All other students: GMAT scores at or above the 50th percentile. Consideration is given to students scoring below the 50th percentile who have a cumulative accounting GPA of at least a 3.0 for accounting courses taken at AACSB Accredited Schools.
- Submit one letter of recommendation. (Three letters are preferred for non-Truman students)
- Submit the following applications:
 - a. University Graduate School Application
 - b. Resume
